## Hotel Leon d'Oro: use of the Wi-Fi network - Verona headquarters

Hotel guests (users) can surf the Internet for free via the browser (using laptops, PDAs, tablets, smartphones or devices with network cards compatible with Wi-Fi protocols) in the points covered by the Wi-Fi network, using the public hotspot (access point) provided by the Hotel itself. The service does not provide technical support for the configuration of users' technical equipment.

The user of the Wi-Fi service:

- is aware that the Wi-Fi network service is provided through the use of shared band frequencies and limited protection against interference; consequently, the quality of the service could, in some moments, be subject to limitations;
- recognizes that Hotel Leon d'Oro is in no way responsible for the content, quality and validity of any information found on the web. The Hotel is also not responsible for the outcome of user transactions, with particular reference to those of a commercial nature that uses electronic payment systems or similar techniques;
- assumes total responsibility for the actions performed during the use of the Wi-Fi service and for the content of the messages transmitted;
- observes the laws in force concerning copyright and privacy protection, as well as the specific criminal laws relating to computer and electronic communication sector, as well as any other general provision of law.

The user is also aware that wireless access provides a way of using the service without data encryption: transmission is clear and access does not require any particular configuration. All this determines that the user is more exposed to the dangers of intercepting the transmitted data, potentially jeopardizing their security and integrity.

Therefore, it is advisable to take the appropriate security measures and any precautions to avoid any attacks on your device.

In particular, when using the Wi-Fi service it is forbidden to:

- carry out any activity that is in contrast with Italian and European legislation;
- access sites, chat rooms, network games that, in terms of content and images, are in contrast with Italian and European legislation;
- access child pornography sites or sites that are inspired by violence and racism;
- send e-mails that are offensive, threatening or annoying to other users of the network and indiscriminately (spamming);
- enter or transmit dangerous viruses or programs to other users;
- transmit messages or images protected by copyright;
- carry out any activity aimed at circumventing or deceiving the access control and / or security systems of any internal or public server;
- use mechanisms or tools of any kind to circumvent the abusive copy protection schemes of the software, to reveal passwords, to identify any security vulnerabilities of the various systems, to decrypt, without being authorized, encrypted files or to compromise the security of the network in any way.

**In general, the user is responsible for any violation of this regulation and relevant legislation.**

The Hotel also **informs** the user that in order to

- guarantee the security of the network infrastructure
- maintain the same
- identify any illegal abuses conduct by users, from which it could derive responsibilities, including criminal, charged to the Hotel

he reserves the right to carry out checks in relation to the correct use of the internet.

If requested, the data acquired must be made available to the Postal and Communications Police Service, the Judicial Authority and the Judicial Police. The data concerning the use of the Wi-Fi network will be stored in strict confidentiality, for a limited period of time, in compliance with current regulations.
